Environmental Quality Report Information

August 18, 2017

It is hard to believe that the end of the summer is almost here! Staff members have been hard at work getting everything ready for the first day of school and are excited to get the school year started.

I want to share an update with you about our school building. As part of a Memorandum of Understanding with the school system, Howard County Government hired an independent contractor to conduct an assessment of Elkridge Elementary School's air quality this past June. In early August, the report was shared on the county government's website. Supplemental to that report, the independent contractor has shared in writing with the school system that "the types and concentrations of airborne mold found in and outside of the schools are typical for public schools in similar geographic regions of the United States for the time of the year the assessment occurred. These types and concentrations of airborne mold spores do not normally pose a health risk." In addition, "Overall, the observations made during the assessments indicate that the HCPSS and maintenance staff at each school is doing a good job of controlling indoor moisture and mold growth, resulting in the protection of health of students and staff."

The contractor has also provided a list of recommendations specific to Elkridge Elementary School. Those recommendations are:

- A reassessment of portable classrooms #'s 77, 110, 155 and 159 as well as the art and music rooms, boiler room, and staff lounge using a moisture meter to identify any building materials exhibiting elevated moisture content.

- If these readings identify elevated moisture levels then walls and/or ceilings should be opened up to visually inspect and determine if hidden mold growth exists.
- To replace stained ceilings/ceiling tiles.
- To identify and correct the source(s) of the water causing the staining.

Our building services staff has these recommendations and will be implementing all of them. I will send an additional communication after the work has been completed. School safety is a top priority and I will work alongside building services to assure that our school bulding and portable classrooms remain safe for students and staff.I will continue to communicate with you and provide updates as they become available.
